### 3.2 POTENTIAL HEALTH EFFECTS

## SECTION 6: ACCIDENTAL RELEASE MEASURES

Accidental Release Measures: Observe precautions from other sections. Ventilate the area. WARNING! ### 7.1 HANDLING
