Introduction

Because of the increased capability of the EVLA, including the greatly expanded capacity of the correlator, we foresee a number of new software developments that will need to be in place when the EVLA comes online. One necessary input to proceed in these developments is a set of scientific requirements on the software. This document defines these requirements for the part of the EVLA software which has been contracted to the Data Management division of NRAO (under the e2e project). It should be noted that this document does not apply to software required to run the VLA currently, or when operating in the “VLA-mode” during the transition period.

Overview

The requirements herein are structured according to the EVLA contract with the Data Management Division of NRAO, which is summarized in project 10 of the EVLA project book (at: <http://www.aoc.nrao.edu/evla/pbook.shtml>). This contract has 6 specific areas:

1. Proposal submission and handling (section 1);
2. Observation preparation (section 2);
3. Real-time observing (sections 5.1 and 5.5);
4. Scheduling of sets of observations (section 3);
5. Archiving of observations (section 4);
6. Pipeline processing including calibration and imaging (sections 5.2 and 5.3).

We have generated EVLA specific requirements in all of these areas to some degree. However, there are several areas of the software effort that we have not addressed in this document. These include the offline data processing (most of the Pipeline processing), proposal handling, and requirements based on engineering considerations. These areas will be considered in separate documents: *EVLA Offline Data Processing Requirements*, *EVLA Operations Software Requirements*, and *EVLA Engineering Software Requirements*. In addition, science requirements for EVLA software which is being completed by the EVLA project itself (not contracted to the DMD) are also considered in a separate document - *EVLA Science Requirements for Real-Time Software*.

We stress here that this is a living document, and subject to revision at any time by the EVLA Software Science Requirements (SSR) committee. The intent is to write down the requirements as completely as possible at a given time, but we must retain the ability to remedy oversights, reflect changes in philosophy with respect to the software, and react to the realities of schedule and budget (via feedback from the e2e and EVLA projects).

The prioritizing scheme is described below. Where possible we have made the requirements quantitative, and clearly defined the meaning of qualifiers and adjectives. However, there are instances where the substance of particular requirements is necessarily subjective (e.g., “ease of use” and “robustness” type requirements). Rather than spelling these out in detail, we have left these “squishy” requirements as-is, and will rely upon the SSR and those charged with evaluating and accepting the software to take these properly into account.

There are also a number of places, such as the headers to sections, where we discuss the philosophy behind our choice of requirements. In those cases, the discussions are given as *italicized* text and are not meant as requirements in and of themselves.

In the numbered sections below, we enumerate requirements in a formal way; these are grouped in sections corresponding to the main software components outlined in this Introduction. In Appendix A we define the main entities, used to manage the whole observing process, that are referred to in the Requirements.

This document is heavily based upon the *ALMA Science Software Requirements and Use Cases* document.

The e2e project is described in much more detail in the *e2e project book*.

General description

Proposals will be submitted by prospective users of the EVLA for evaluation by a scheduling committee (with input from external referees). Proposals contain all information that is necessary for the scheduling committee to make a decision on awarding observing time, including sources to be observed (with characteristics), frequencies, configurations, etc..., and a scientific justification. It is envisioned that the preparation and submission of proposals are contained in a single software "Tool" - the Proposal Tool. This tool might also be used to manage the proposals for the observatory, but that is an operations decision which is beyond the scope of this document.

A Tool could be a stand-alone program or set of scripts, or might be an integrated part of a larger software package. This is a question of implementation and as such is beyond the scope of this document. We do require in many instances, however, that different Tools be able to "speak" to each other, i.e., can pass information back and forth. We also strongly recommend that if they are separate implementations that they at least have a common look-and-feel.

If awarded time by the scheduling committee, the observer must then provide more detailed information on how to go about observing the desired sources. The intent should be to make this process as simple as possible for inexperienced users (e.g., as simple as saying "I would like a map of Cygnus A at 8.5 GHz with 1" resolution and 1 μ Jy rms noise"), and yet should allow the experienced observer enough power and flexibility to command the telescope in any desired (but still sensible) way. It is envisioned that this task is handled by another Tool - the Observing Tool.

Both the Proposal Tool and the Observing Tool will include at least minimal models of the EVLA and the site in order to give guidance, e.g., on whether a proposed observation is possible, or whether a different method of observing will produce superior results. This will aid in the preparation of proposals and also in the creation of the program blocks (observation description). This can build on common software, as discussed above. Note that it might be possible to do more complex, and more realistic, simulations of EVLA observing using the Data Post-processing Package, but this will not be discussed in this document further.

The Observing Tool creates a description of an observing program which is then sent to the Scheduling Tool. The Scheduling Tool is what actually tells the telescope what to go off and observe next. Dynamic scheduling is an essential feature of the instrument and should be installed from the very beginning of its operational life. To improve the total efficiency we must be able to make the best use of all weather conditions, by selecting in quasi-real time the project most suited to the current weather and to the state of the array. This means we should always be able to observe a given project in appropriate weather conditions. This philosophy can be extended to the point where a given project can change its own observing parameters according to variations in observing conditions (such as atmospheric phase rms).

At this point in the information flow, we leave the regime which is the responsibility of the e2e project, and control is passed over to the EVLA real-time software, described in a separate document. The instrument collects the requested data, and provides it at the backend, where control is handed back over to the e2e software. The dividing lines between the control in these two areas need much firmer definition, but that too is outside the scope of this document.

After data are collected and archived, they must be retrieved by the Archive Tool. All related observational and technical auxiliary data must be accessible to the observer through the archive. The Archive Tool is conceptually divided into two sections: the Archive Search Tool (which finds the data), and the Archive Retrieval Tool (which actually goes and gets it). The archive stores not only raw data, but also processed images and spectra, calibration data, and even pointers to outside references relevant to projects contained therein. In addition to having its own search tool, the archive allows access via queries from the National Virtual Observatory (or its functional equivalent).

At the same time as data are fed to the archive, they may also be fed to a data reduction pipeline (conceptually, at any rate - whether the data are first fed into the archive and then immediately retrieved from the archive for input into the pipeline is a question of implementation). We envision the following types of operations which might be considered as 'pipeline' related: real- (or near-real) time calibrator analysis; production of quick-look images

and/or spectra; production of default images and/or spectra for the archive; user-controlled production of images and/or spectra from data contained in the archive. The 3rd and 4th of these are really off-line processing operations, and so we defer most discussion of them to the document discussing that topic. The pipeline that produces the quick-look images and/or spectra must be able to take data as they are produced by the EVLA and flag, calibrate, map, deconvolve, etc... it to produce images and spectra. Because of this, the pipeline must have access to current calibration data including bandpass, polarization, flux density scale, phase and amplitude, antenna efficiency, etc..., and to other parameters like current atmospheric opacity. The pipeline then produces images and spectra which are made available to the operator(s) and to the observer(s). The calibration data necessary for not only the quick-look pipeline, but also for things like autophasing the array, are obtained by the real- (or near-real) time calibrator analysis tool. This is a set of high level functions built around what in the current on-line system is called ANTSOL.

The Tools described herein all interact with each other. For instance, we imagine a prospective observer invoking the Proposal Tool, and while creating the proposal, requesting a simulation of the observation (from within the Proposal Tool). To simulate the observation, the Observing Tool is invoked from the Proposal Tool to determine how to actually perform the observations. The data created by the simulation are fed to the Pipeline Tool, which reduces the data (e.g., makes a map and deconvolves it). The results are then available in the Proposal Tool. The observer then makes a query into the Archive Tool to see if this observation has already been done, and if so, may request the data, and feed them into the Pipeline Tool (although this last exercise may be considered part of the off-line data processing). Again, these can all be separate 'programs' (or the functional equivalent), but they need to be callable from each other, and it is extremely desirable that they have a common look-and-feel for any interactive access. They should also be developed in a highly consistent way, from the very beginning of design. They may, however, be installed progressively provided the critical elements are implemented first.

Some details

The expert user/developer will need to be able to send direct commands to the instrument through a simple, easily editable command language. Atomic commands in a script language will directly send orders to the basic software elements controlling the hardware: antenna motion, instrument setup, or transmitting parameters to the data processing (pipeline). The script language will support loops, structured conditional tests, parameterized procedures, global variables and arrays. These scripts, once fully developed and tested, will evolve into the basic observing procedures of the instrument.

The general user will need more user-friendly graphic interfaces to many components of the system. They will propose several templates, corresponding to the available observing modes, and provide a simple way to pass parameters to the basic observing process, and to the corresponding data reduction procedures of the pipeline. Input parameters will preferably be expressed in terms of astronomical quantities, which will be translated into technical parameters by sophisticated configuration tools.

In writing this set of requirements, we have made a number of specific assumptions about how the EVLA is to appear to users and staff. These are:

1. The EVLA software shall offer an easy to use interface to any user and should not assume detailed knowledge of radio astronomy and of the EVLA hardware.
2. The EVLA software shall provide simple ways for the staff or expert astronomers to refine observing modes and develop new ones.
3. The general user shall be offered fully supported, standard observing modes to achieve the project goals, expressed in terms of science parameters rather than technical quantities. Observing modes shall allow automatic fine tuning of observing parameters to adapt to small changes in observing conditions.
4. All user interaction with the EVLA shall be through **Graphical User Interfaces** (GUIs) with only a few exceptions (e.g., the ability to type Control Scripts directly into the real-time system when observing in manual mode).

5. The instrument shall be dynamically scheduled on timescales from near real time (a few minutes in advance of real time) to several hours into the future, to take full advantage of the atmospheric conditions and of instrument availability. The scheduler will work from a queue of scheduling blocks with priorities. For interactive or manual mode, the observer will have control of the queue.
6. The EVLA final product shall be images for the large majority of projects. The data shall be calibrated and processed in pipelines, which will be both automated and easy to change (and use) interactively.
7. Observing descriptions (Program Blocks, Schedule Blocks, and Control Scripts), raw data, monitor data, calibration data, and images will be archived; archived data shall be easily accessible to the users.
8. The EVLA processing system shall be able to handle an initial peak data rate of 20 MB/s. This corresponds roughly to one million (double-precision complex) visibilities per second (1.0 MVPS), and one-half million (double-precision) image pixels per second (0.5 MPPS). The final peak data rate is 5 GB/sec. The correlator is capable of producing as much as 352 GB/sec! See Tim Cornwell's *EVLA Memo 24* for an analysis of the EVLA processing needs.
9. Data processing pipelines will make available and display for the use of operations any system element performance measures they develop in the course of calibration.
10. It is expected that there will be close and frequent collaboration between the e2e programmers and the EVLA SSR committee members during software development (on a much shorter timescale than the 9 month formal development cycle for e2e).

We have not attempted to specifically require that the software run on a preselected set of platform/OS combinations. It should be obvious that the goal is to have software that is as platform/OS independent as possible. We currently foresee a need for support of at least Windows (XP or 2000), Mac (OS X), and Linux variants, but that list should not be considered as inclusive, and is subject to change.

Priorities

We have developed a 2 dimensional priority scheme, which encompasses both the importance and the timescale for a particular requirement.

The importance can have the following values:

- 1** = essential
- 2** = important
- 3** = desirable, but not critical

It is intended that Priority 1 items must be present and work with high efficiency. Priority 2 items should be present, though there may have to be sacrifices in performance or availability may be delayed. We expect that the software will fulfill all Priority 1 and 90% or more of Priority 2 requirements. Priority 3 items should be considered for upgrades or development.

The timeframe of deployment is matched to the EVLA Phase I Project schedule (see the *EVLA Project Book*). The timescale phases are:

- A** transition phase (2004 Q2)
- B** prototype correlator (2005 Q4)
- C** shared-risk Science operations (2007 Q2)
- D** full science operations, completion of EVLA Phase I (2010 Q2)
- E** "eventually" sometime after completion (ongoing)

These are the same as the priorities which will be used in *EVLA Data Post-processing Science Requirements*.

1 Proposal generation and submission requirements

These requirements cover the preparation and submission of proposals for EVLA observing time, which are to be evaluated by the scheduling committee.

1-R1 There shall be a Proposal Tool for the preparation and submission of proposals for the EVLA.

Priority: 1 Timescale: C

1-R1.1 The Proposal Tool, Observing Tool, Scheduling Tool, Pipeline Tool, and Archive Tool shall be integrated into a common software package, or at least be able to be invoked from each other and pass data back and forth, and have a common look-and-feel for any interactive access.

Priority: 1 Timescale: D

1-R2 The proposals shall be submitted electronically and all observer input shall be in digital form.

Priority: 1 Timescale: C

1-R3 The Proposal Tool shall allow storing of intermediate stages to local disks.

Priority: 1 Timescale: C

1-R3.1 This stored version shall be easily transferred (across platforms) between co-authors and collaborators.

Priority: 2 Timescale: C

1-R3.2 This stored version shall be easily editable with normal text editors (i.e., should be normal printable ASCII text).

Priority: 3 Timescale: D

1-R4 If the Proposal Tool stores input information on NRAO computers for later modification (intermediate stages), then access to that information should be restricted via a password generated uniquely for that proposal, emailed only to the author of that proposal.

Priority: 1 Timescale: C

1-R5 Proposals output from the tool shall be readable by the tool.

Priority: 1 Timescale: C

1-R6 The Proposal Tool should require input of the following information:

1-R6.1 Proposal title;

1-R6.2 Proposal author information, including name, institution, presence at EVLA for observations, whether the observations are for a Ph.D. thesis, and if so, anticipated graduation year. It should be possible to enter this information:

1-R6.2.1 via direct input into the tool;

Priority: 1 Timescale: C

1-R6.2.2 by selection from a database of such information (at least for name and institution);

Priority: 2 Timescale: C

1-R6.3 An indication of which author is the contact author, and contact information for that author, including address, phone number, and email address. It should be possible to enter this information:

1-R6.3.1 via direct input into the tool (in this case, such information may be “normalized” by NRAO at the proposal handling stage, i.e., made consistent with previous or other entries or observatory standards);

Priority: 1 Timescale: C

1-R6.3.2 by selection from a database of such information;

Priority: 2 Timescale: C

1-R6.3.2.1 the proposer should be able to indicate that the information in the database is out-of-date and provide new information for the database (this information may be “normalized” by NRAO after reception before entry into the database).

Priority: 2 Timescale: C

- 1-R6.4** References to previous proposals related to this one (these may also be added at the proposal handling stage by the observatory);
- 1-R6.5** The category of observation, selectable from a list of, e.g., solar system, galactic, extragalactic, other;
- 1-R6.6** The type of observation, selectable from a list of, e.g., continuum, spectroscopy, polarimetry, solar, pulsar, mosaicing, other, etc...;
- 1-R6.7** Keywords which apply to the proposal (from a list provided by the observatory - example lists are those used by astronomical journals [AJ or ApJ]);
- 1-R6.8** An indication of whether observations from other telescopes will also be necessary (e.g., for combining GBT data with mosaiced EVLA data, or for planetary radar), which telescopes are required, whether observing time has already been obtained on them, if so, what are the dates/times, if not, when will it be known;
- 1-R6.9** A short summary (abstract) of the proposed observations and scientific justification, length to be set by NRAO management, and enforced by the tool if possible;
- 1-R6.10** An indication of the level of staff help required (e.g., none, light consultation, heavy consultation, staff collaborator);
- 1-R6.11** An indication of whether the data will be reduced at the observers home institution or at the AOC;
- 1-R6.12** An indication of preferred dates, or dates that should not be allowed (i.e., prioritization as a function of date).

Priority: 1 Timescale: C

1-R7 The Proposal Tool should support source lists.

- 1-R7.1** The tool should require entry, for all sources, of all fields useful to decide scientific priority and technical feasibility. These include:
 - 1-R7.1.1** Common name;
 - 1-R7.1.2** Coordinates;
 - 1-R7.1.3** Requested VLA configurations;
 - 1-R7.1.3.1** it should be possible to simply input the range of spatial scales (maximum and minimum) of interest (the maximum is already specified below in Requirement 1-R7.1.6, the minimum spatial scale is just the desired resolution), and, along with the frequency (or frequencies - see Requirement 1-R7.1.4), the tool should then automatically supply the required configuration(s).
 - 1-R7.1.4** Requested observing frequencies;
 - 1-R7.1.5** Continuum flux density;
 - 1-R7.1.6** Angular size of largest structure;
 - 1-R7.1.7** Required continuum rms (or, equivalently, required dynamic range);
 - 1-R7.1.8** Requested number of antennas (in the case that subarrays are desired - note that the default should always be that all antennas are requested);
 - 1-R7.1.9** Requested time on source.
 - 1-R7.1.9.1** the tool should supply an “exposure time calculator”, which will calculate the required time on source, given all of the other inputs in this section (including spectroscopy inputs below).
- Spectroscopic observations also include:
- 1-R7.1.10** Line identifications or frequencies;
 - 1-R7.1.11** Requested frequency or velocity resolution;
 - 1-R7.1.12** Requested frequency, velocity or redshift range;
 - 1-R7.1.13** Required rms in a spectral channel;
 - 1-R7.1.14** Flux density at line peak.

Priority: 1 Timescale: C

1-R7.2 The submission tool shall supply a flexible interface for importing the source information from another medium, e.g., as an imported file listing the above information.

Priority: 1 Timescale: C

1-R7.3 There shall be a mechanism for specification of source selection parameters in lieu of an enumerated source list, in order to facilitate the target definition for large surveys.

Priority: 2 Timescale: D

1-R7.4 The submission tool shall provide access to catalogs such that sources can be imported by common name, including at least 3C, 4C, NGC, Markarian, and UGC. Consistency between positions and names of type Bnnnn+nnn, Jnnnn+nnn, and Gnnn.n+n.n shall be enforced. Consistency between entered names, positions, and the above catalogs shall be enforced.

Priority: 2 Timescale: D

1-R7.5 The submission tool shall allow access to a pulsar catalog, whose format shall be XML, with a well-defined schema, provided by the observatory.

Priority: 2 Timescale: D

1-R7.6 The submission tool shall be able to calculate the position, distance, size, and flux density as a function of frequency of the Sun, Moon, major planets, satellites, and asteroids (all bodies $\gtrsim 200$ km diameter), and be able to insert them into the source list. Note that at this point, extremely accurate positions are not needed - they are merely a guide to the scheduling committee.

Priority: 2 Timescale: D

1-R7.7 The submission tool should allow for entry of orbital elements (as a 6 element vector) for other solar system bodies, and from those orbital elements, calculate coordinates.

Priority: 3 Timescale: E

1-R7.8 A connection to commonly available astronomical databases (e.g., the CDS and NED databases) shall be available.

Priority: 3 Timescale: E

1-R8 The Proposal Tool should require the input of the scientific justification, which should be a single file prepared by the observer in one of a small number of preferred formats (ASCII, PostScript, or PDF). The allowable size of the scientific justification is to be set by NRAO management (preferably in number of pages), and enforced if possible by the Tool.

Priority: 1 Timescale: C

1-R9 The Proposal Tool shall allow for the input of requirements on observing conditions. These can be in the form of crude indicators (“any”, “average”, “good”, “exceptional”, etc...), a requirement on the specific rms phase of the atmospheric phase monitor, a requirement on the wind speed, a requirement on the opacity, or a specification of “stringency” (see Appendix A for a definition of stringency), or combinations thereof.

Priority: 1 Timescale: C

1-R10 The Proposal Tool should allow for an indication that a proposal is for Target-of-Opportunity Observations (TOO).

Priority: 1 Timescale: D

1-R10.1 The Proposal Tool should allow for an indication of whether this is a Type 1 or Type 2 TOO (Type 1 are relatively common but, in detail, unpredictable phenomena, Type 2 are newly discovered bodies or phenomena and truly exotic events).

Priority: 1 Timescale: D

1-R10.2 For Type 1 TOO proposals, the Proposal Tool should allow for an indication of what should trigger the observation.

Priority: 2 Timescale: D

1-R11 The Proposal Tool shall perform certain simple calculations, including:

1-R11.1 the integration time required:

1-R11.1.1 for a given bandwidth and channel (e.g., velocity) width;

Priority: 1 Timescale: C

1-R11.1.2 under poor, average and good observing conditions;

Priority: 1 Timescale: C

1-R11.1.3 using real observing statistics;

Priority: 2 Timescale: D

1-R11.1.4 for the measured RFI environment;

Priority: 2 Timescale: D

- 1-R11.1.5** given sky coordinates, for low frequency (the Tool should know about the distribution of background temperature and confusing sources).
Priority: 3 Timescale: E
- 1-R11.2** the calculation of integration time should incorporate simple calibration overhead heuristics (TBD).
Priority: 1 Timescale: C
- 1-R11.3** the appropriate configurations needed given desired brightness sensitivity, resolution, and source angular size.
Priority: 1 Timescale: C
- 1-R11.4** the amount of time required to achieve a specified rms level, given the specification of required observing conditions (e.g., required phase stability at the specified frequency).
Priority: 2 Timescale: D
- 1-R12** The tool shall calculate the data rate and the total data volume for the project.
Priority: 1 Timescale: C
- 1-R12.1** The tool shall calculate the data processing load as per EVLA memo 24.
Priority: 2 Timescale: D
- 1-R13** The tool shall react to user input by providing warnings based on the situation and selected observing mode, including:
- 1-R13.1** hardware limitations, including feasibility of using the correlator at the requested spectral resolution and total bandwidth;
Priority: 1 Timescale: D
- 1-R13.2** data rate/volume;
Priority: 1 Timescale: D
- 1-R13.3** expected data quality;
Priority: 2 Timescale: D
- 1-R13.4** expected stringency limitations (e.g., weather, RFI, ionospheric conditions).
Priority: 2 Timescale: D
- 1-R14** There shall be the facility to search a database of previous observations of objects for a proposal, with the results returned to the proposer, as well as being made accessible to the scheduling committee. This might be effected by calling the Archive Search Tool (but this is an implementation question).
Priority: 1 Timescale: C
- 1-R14.1** The search results should be ordered by relevance, with relevance weighted (in this order) by selected:
- source name or coordinate;
 - observing frequency;
 - resolution or configuration;
 - required or achieved rms;
 - date (closest to specified date, with default being the current date).
- Priority: 2 Timescale: D*
- 1-R15** The basic input parameters shall be translated by the tool into control parameters (e.g., observing mode, configurations, observing time, correlator setup) which the expert shall be able to check. These can be overridden manually (e.g., by EVLA staff).
Priority: 2 Timescale: C
- 1-R16** There shall be a facility to take all of the information contained in the proposal (i.e., that described in Requirements 1-R6, 1-R7, 1-R8, 1-R9, and 1-R10) and turn it into a printable electronic document (a PostScript or PDF file), which can be easily accessed by the user (either by being stored on a local disk, or easily downloaded from an NRAO computer). If NRAO operations has a requirement on the particular layout and format of such hard copy, it shall be recognized.

1-R17 There shall be a facility to formally submit the proposal for consideration by the scheduling committee, i.e., to bundle up all information described in Requirements 1-R6, 1-R7, 1-R8, 1-R9, and 1-R10, and make it available to NRAO (e.g., via emailing the information directly, or by placing it in a location where it can be easily accessed by NRAO operations staff on an internal computer, and emailing a pointer to its location). Additional information shall be calculated at the time of submission, and included as part of the Proposal:

1-R17.1 Submission date and time;

1-R17.2 A list of all configurations and wavelengths being asked for (this can be compiled by the tool given the information in the source list);

1-R17.3 The total time being requested in this proposal (this can be compiled by the tool given the information in the source list);

Priority: 1 Timescale: C

2 Observation preparation requirements

These requirements cover the preparation of Program Blocks (collections of Schedule Blocks) for submission to the Scheduling Tool by the observer using the Observing Tool.

It is envisioned that a Project consists of one or more sets of Program Blocks, which are in turn sets of Scheduling Blocks that are submitted as a group to the Scheduling Tool for scheduling purposes. For example, a Project might include Program Blocks for each of A and B configurations for a given target.

We note here that the Observing Tool is extremely important, in that it is the second point of contact for many observers (the first being the Proposal Tool), and the first one in which they interact in a more detailed way with the EVLA instrument. Because of this, it is very important that this tool be robust and easy to learn and use. We do not want to repeat the experience of OBSERVE and JOBSERVE.

2.1 The Observing Tool

2.1-R1 There shall be an Observing Tool for the generation of Program Blocks as input to the Scheduling Tool.

2.1-R1.1 The Proposal Tool, Observing Tool, Scheduling Tool, Pipeline Tool, and Archive Tool shall be integrated into a common software package, or at least be able to be invoked from each other and pass data back and forth, and have a common look-and-feel for any interactive access.

2.1-R4 Since the Observing Tool is the primary interface of the observer to the EVLA, it should be easy-to-use and robust:

2.1-R4.1 This tool shall operate using a GUI;

2.1-R4.2 There shall be built-in help capability;

Priority: 1 Timescale: C

2.1-R4.3 There shall be a batch or script mode for automated generation of Program Blocks;

Priority: 1 Timescale: D

2.1-R4.4 The use of the Observing Tool shall not entail an excessive learning curve. Average users, with some knowledge of radio astronomy (as obtained by attending the NRAO Summer School) shall be able to become proficient in using the tool on a timescale of roughly 1 working day of dedicated use, and truly neophyte users (e.g., graduate students in other areas of astronomy) should reach proficiency with an investment not exceeding a few working days of dedicated use;

 - 2.1-R8.2.1** direct entry into the tool;

 - 2.1-R8.2.3** user-supplied source lists in ASCII format;
Priority: 1 Timescale: C
 - 2.1-R8.2.4** the source list from the proposal;

 - 2.1-R8.3** Allow the user to easily construct a *Source List* from the source catalog which contains all of the sources to be observed. Sources in the Source List should be selectable via:

- 2.1-R8.3.1** interactive selection from the source catalog;

- 2.1-R8.3.2** sequential extraction of targets from a list of sources (e.g., to conveniently schedule survey programs);

 - 2.1-R11.1** The ability to specify the desired spatial and spectral extent of the final image cubes.
Priority: 1 Timescale: D
 - 2.1-R11.2** The ability to specify the desired u-v tapering and weighting (e.g., robustness parameter) for creation of the final image cubes.
Priority: 1 Timescale: D
 - 2.1-R11.3** The ability to specify the desired frequency or velocity selection, averaging, smoothing, etc..., of the final image cubes.
Priority: 1 Timescale: D
 - 2.1-R11.4** A mechanism for the observer to convey intent to the pipeline, including at least the following information:
 - 2.1-R11.4.1** How calibrators are to be used (see Requirement 2.1-R10.4);

2.1-R12 The Observation prediction component shall be able to:

2.1-R12.1 estimate S/N;

Priority: 2 Timescale: D

2.1-R12.2 estimate synthesized beam size;

Priority: 2 Timescale: D

2.1-R12.3 estimate primary beam size;

Priority: 2 Timescale: D

2.1-R12.4 estimate surface brightness sensitivity;

Priority: 2 Timescale: D

2.1-R12.5 estimate range of angular scales well sampled;

Priority: 2 Timescale: D

2.1-R12.6 produce dirty beams;

Priority: 3 Timescale: D

2.1-R12.7 effect its calculations on execution timescales on the order of 10 seconds or less, and should not require significant computational resources;

Priority: 3 Timescale: D

2.1-R12.8 for suitable source models, simulate maps with the desired array configurations;

Priority: 3 Timescale: E

2.1-R12.9 provide simulated spectra based on physical models and given observing parameters.

Priority: 3 Timescale: E

Note: The observation prediction component of the Observing Tool would preferably use common software to the prediction components of the Proposal Tool (see above) to ensure consistency.

2.1-R13 The Observing Tool shall have a “check” function, in which it presents expected sensitivities on all target sources, as well as verifying correlator modes, LO setups, etc.

2.2-R3.1 There shall be the facility to support contingent priority (see below), such that the priorities of subsequently queued blocks are adjusted based upon the results of execution of previous blocks, e.g., the time since execution of a previous block to ensure the desired time spacing of monitoring observations.

Priority: 2 Timescale: D

2.2-R4 The proposer shall be able to specify what is needed for real-time checking of data quality, including:

2.2-R4.1 choosing a standard calibrator as a *test source* to be observed to assess the conditions for stringency;

Priority: 3 Timescale: D

2.2-R4.2 option for the system to automatically choose the test source at execution time.

Priority: 3 Timescale: E

3 Observation scheduling requirements

These requirements refer to the scheduling of programs for actual observation (i.e., using the Scheduling Tool), with the actual Scheduling Blocks that form a given Program Block being provided by the Observing Tool (see Section 2.2).

It is envisioned that the Scheduling Tool is a software program (or equivalent), accessed only by the operator and NRAO staff.

3.1 The Scheduling Tool

3.1-R1 There shall be a Scheduling Tool whose function is to pass a Control Script to the EVLA real-time system to control the telescope.

Priority: 1 Timescale: B

3.1-R1.1 The Proposal Tool, Observing Tool, Scheduling Tool, Pipeline Tool, and Archive Tool shall be integrated into a common software package, or at least be able to be invoked from each other and pass data back and forth, and have a common look-and-feel for any interactive access. Note that it is not required that observers be given access to the Scheduling Tool, but operators and NRAO staff must have access to it.

Priority: 1 Timescale: D

3.1-R2 The input to the Scheduling Tool shall consist of Program Blocks (PB), each of which is a set of Scheduling Blocks (SB) from the same Program.

3.1-R2.1 The execution of an SB shall not be interrupted by the scheduling process (except possibly through an error condition or manual intervention).

Priority: 1 Timescale: B

3.1-R2.2 An SB can be executed again (in order to reach the required sensitivity level, or if it had failed for hardware reasons), but cannot be restarted in the middle of its execution.

Priority: 1 Timescale: B

3.1-R3 The Scheduling Tool shall handle the observing for the EVLA in the main modes:

3.1-R3.1 Manual mode: a facility shall be provided for direct submission of Control Scripts to the real-time system, either from a file, or directly from keyboard input.

Priority: 1 Timescale: B

3.1-R3.2 Normal mode: normal EVLA observing shall be dynamically scheduled in quasi-real time based upon the queue of SBs.

Priority: 1 Timescale: C

3.1-R3.3 Interactive mode: a facility shall be provided for the normal dynamic queue to be suspended, and control passed over to an observer (e.g., overriding priorities in the main queue, or through use of an auxiliary queue) so that the observer can submit a PB or SBs for immediate observing.

Priority: 1 Timescale: C

3.1-R4 The Scheduling Tool shall support observing in multiple subarrays;

Priority: 1 Timescale: C

3.1-R5 The Scheduling Tool should display in a window the current status of the queue, including the SB currently being observed, the next few scheduled SBs, and SBs currently under consideration with high priority.

Priority: 1 Timescale: C

3.1-R6 The Scheduling Tool shall have a facility enabling the operator or NRAO staff to abort the current SB and interrupt the normal operation of the queue. Any aborted SB is automatically reinserted into the queue.

Priority: 1 Timescale: C

3.1-R7 The Scheduling Tool shall have a facility enabling the operator or NRAO staff to modify the priorities of SBs in the queue. Such priority modifications shall always have an associated length of time, which shall be specified at the time of the change (e.g., for the next hour, for the next day, forever).

Priority: 1 Timescale: C

3.1-R8 The Scheduling Tool shall be able to run off-line using recorded historical inputs or simulated inputs, to facilitate debugging and tuning of parameters.

Priority: 1 Timescale: B

3.1-R9 The objective of dynamic scheduling shall be to produce the highest scientific output per unit time. Because of uncertainties in future weather and the possibility of transient phenomena that might occur, an absolute solution for this is not possible. A heuristic approach is required.

3.1-R9.1 Algorithms and heuristics shall be clearly documented.

Priority: 1 Timescale: C

3.1-R9.2 Parameters and weights involved in the heuristics shall be documented, and easily adjustable.

Priority: 1 Timescale: C

3.1-R10 The Scheduling Tool shall check submitted Scheduling Blocks for correctness, to prevent malformed SBs from being executed.

Priority: 1 Timescale: C

3.1-R11 For SBs that indicate so, the Scheduling Tool should be able to choose an appropriate calibrator:

3.1-R11.1 When the SB is being considered for scheduling, in the case that a list of possible calibrators with associated dates, or a list of possible calibrators associated with a moving source, is provided in the SB;

Priority: 1 Timescale: C

3.1-R11.2 After being chosen for scheduling, if there is an indication that the “best” calibrator (either from a provided list, or from an indication that an area of sky is to be searched) should be found at the time of observing, then the Scheduling Tool should submit a short Control Script to the real-time system to initiate this, and use the output from the Real-time Calibrator Analysis Tool to make the decision of which calibrator to use, based on a set of provided heuristics (TBD).

Priority: 2 Timescale: D

3.1-R12 For SBs that indicate so, the source-calibrator cycle time, and amount of time spent on each, should be calculated by the Scheduling Tool, based on current observing conditions (opacity, phase stability, etc...).

Priority: 2 Timescale: D

3.1-R13 For SBs that indicate so, source positions must be able to be inserted after the SB is in the queue.

Priority: 2 Timescale: D

3.1-R14 For observations of moving sources, the Scheduling Tool must insert appropriate calibrators into the Control Script (lists with dates are provided in the SB), and must calculate accurate target source position and velocity trajectories based on:

3.1-R14.1 an internal ephemeris calculator (for all solar system bodies $\gtrsim 200$ km diameter - note that this must be a very accurate ephemeris);

Priority: 1 Timescale: C

3.1-R14.2 provided orbital elements;

Priority: 1 Timescale: C

3.1-R14.3 provided tabulated positions and velocities as a function of time (e.g., output from the JPL horizons system);

Priority: 1 Timescale: C

3.1-R14.4 provided solar longitude and latitude;

Priority: 3 Timescale: E

3.1-R15 As SBs are scheduled, feedback to the observers (PIs) shall be the following:

- 3.1-R15.1** A Scheduler web page is maintained which lists priority ranked programs;
Priority: 1 Timescale: C
- 3.1-R15.2** An email is sent to the PI when the first of his/her SBs is executed for the first time;
Priority: 1 Timescale: C
- 3.1-R15.3** A final email is sent at the end of the program (when all the data are archived and available).
Priority: 2 Timescale: C
- 3.1-R15.4** A Project Web page is created (with password or other access protection) which gives the current status of the Project.
Priority: 2 Timescale: D
- 3.1-R15.5** An email is sent to the PI when the first of his/her SBs gets for the first time into the top ~ 10 ranked ones, as an announcement of approaching execution (but not a guarantee, the weather being not easily predicted);
Priority: 2 Timescale: D
- 3.1-R15.6** The Project web page is updated at regular intervals (e.g., each SB, or ~ 10min whichever is longest). This includes the quick look image, quality check information from the quick look pipeline, and general execution status of the program;
Priority: 3 Timescale: D

3.2 Scheduling Operations

- 3.2-R1** The order of execution of Scheduling Blocks from the queue shall be on the basis of an assigned dynamic priority.
Priority: 1 Timescale: B
 - 3.2-R1.1** The decision for the next SB to execute shall be made shortly before the end of the scheduling block currently in execution.
Priority: 1 Timescale: C
- 3.2-R2** The dynamic priority of a given SBs shall be calculated at the decision time based upon the criteria:
 - 3.2-R2.1** Availability of the SB for scheduling. An SB will not be scheduled (dynamic priority set to zero) if its principal direction is below the horizon (or if some other staff-entered LST constraint is not met), if the required observing conditions (e.g., number of functioning antennas, phase rms, wind speed, opacity, RFI, solar interference, etc...) are not met or would compromise the observations with the specified observing parameters (including a consideration of whether self-cal will help or not);
Priority: 1 Timescale: B
 - 3.2-R2.2** Scientific Value (see below);
Priority: 1 Timescale: B
 - 3.2-R2.3** Relative Priorities assigned by the observer using the Observing Tool;
Priority: 1 Timescale: C
 - 3.2-R2.4** Environmental Priority Modifiers based upon current conditions;
Priority: 1 Timescale: C
 - 3.2-R2.5** Contingent Priorities (see below);
Priority: 2 Timescale: D
 - 3.2-R2.6** Operational Priorities (see below);
Priority: 2 Timescale: D
- 3.2-R3** The following criteria will be used in evaluating the Scientific Value of an SB:
 - 3.2-R3.1** Science rating as determined by the scheduling committee and the referees;
Priority: 1 Timescale: B
 - 3.2-R3.2** Proximity to a preferred date or LST (e.g., for emulation of fixed-time scheduling for placing observations near observations made with another instrument, or hitting a particular phase of a variable object);
Priority: 1 Timescale: C

- 3.2-R3.3** Suitability of the phase of a periodic phenomenon (for instance the phase of a close binary star, or the orbital phase of a planetary satellite);
Priority: 2 Timescale: C
- 3.2-R3.4** The contribution of the execution of the scheduling block to the program. (That is, the contribution to the sensitivity, taking into account the system temperature at the current elevation, atmospheric opacity and/or ionospheric conditions, current or past RFI environment, and the number of available antennas, is to be considered, not just the time.);
Priority: 3 Timescale: D
- 3.2-R4** There can also be Contingent Priorities, which are modifiers arising at decision time based upon the results of the execution of other SBs from the same Program Block. These might include:
- 3.2-R4.1** Elapsed time since previous execution (for monitoring variable objects at a regular rate);
Priority: 2 Timescale: D
- 3.2-R4.2** Hour Angle or Parallactic Angle spacing since previous execution (for improving uv or parallactic angle coverage);
Priority: 2 Timescale: D
- 3.2-R5** Environmental Priority Modifiers include:
- 3.2-R5.1** Current local weather conditions (temperature, dew point, wind speed);
Priority: 1 Timescale: C
- 3.2-R5.2** Current atmospheric conditions (opacity and phase rms at the observing frequencies used in the SB - note that this assumes the availability of this information in the Scheduling Tool, which may require auxiliary instruments such as an atmospheric phase monitor or a tipper meter, the data from which must be treated appropriately [e.g., raw output from the phase monitor is turned into phases vs. time which are then used to derive the rms phase at the frequency of the phase monitor, which is then used to derive the rms phase at the observing frequency; or raw output from the tipper is turned into atmospheric temperatures vs. elevation which are then used to derive opacity at the tipper meter frequency which is then used to derive the opacity at the observing frequency]);
Priority: 1 Timescale: C
- 3.2-R5.3** Current ionospheric conditions (phase rms at the observing frequencies used in the SB - this may require processing of raw data from GPS receivers or other auxiliary devices to derive the phase rms);
Priority: 1 Timescale: C
- 3.2-R5.4** Current RFI conditions at the observing frequency (or frequencies), if known.
Priority: 1 Timescale: C
- 3.2-R5.5** Stringency factor: SBs requiring rare conditions may be preferred when those conditions occur.
Priority: 2 Timescale: D
- 3.2-R5.6** Predictions of future observing conditions (far enough into the future to complete the SB), including possibly detailed weather predictions from mesoscale models or as provided by the National Weather Service, if possible.
Priority: 2 Timescale: D
- 3.2-R6** Depending upon the algorithm chosen for implementation of the system, the following heuristics may also be appropriate to consider for Operational Priorities:
- 3.2-R6.1** The status of the Program as a whole (preference should be given to finishing a Program Block once it is started);
Priority: 2 Timescale: D
- 3.2-R6.2** The status of the Project as a whole (preference should be given, for example, to getting a small amount of D configuration time to provide short spacings for a project that already has a large amount of B configuration time).
Priority: 2 Timescale: D
- 3.2-R7** Special calibration observations may be required at the beginning and/or end of execution of one or more SBs, which we denote as preamble and postamble blocks. These are particular versions of Control Scripts. The Scheduling Tool must account for these when determining priority, e.g., if a particular SB requires long

preamble and postamble blocks, that should be factored into the required time to complete the SB, modifying its priority.

Priority: 2 Timescale: D

3.2-R8 Pipeline results from the astronomical targets themselves (for instance, test point sources) can be used in computing scheduling block priorities.

Priority: 3 Timescale: D

4 Archiving requirements

4.1 Archive Definition

4.1-R1 There shall be an EVLA archive which stores all data obtained with the EVLA. This archive shall include:

4.1-R1.1 interferometer data taken for any reason (science, testing, calibration);

Priority: 1 Timescale: C

4.1-R1.2 environmental data (e.g., weather data, WVR, APM, GPS);

Priority: 1 Timescale: C

4.1-R1.3 monitor and control data;

Priority: 1 Timescale: C

4.1-R1.4 project data:

4.1-R1.4.1 proposal, PBs, operator logs;

Priority: 1 Timescale: C

4.1-R1.4.2 links to papers, related data, etc...

Priority: 3 Timescale: E

4.1-R1.5 data products (e.g., calibrated data and images from the pipeline);

Priority: 1 Timescale: D

4.1-R2 There shall be an Archive Tool capable of accessing (including searching and retrieving) the information in the archive.

Priority: 1 Timescale: C

4.1-R2.1 The Proposal Tool, Observing Tool, Scheduling Tool, Pipeline Tool, and Archive Tool shall be integrated into a common software package, or at least be able to be invoked from each other and pass data back and forth, and have a common look-and-feel for any interactive access.

Priority: 1 Timescale: D

4.1-R3 There shall be a backup for the archive to protect the data from catastrophic failure and loss.

Priority: 1 Timescale: C

4.1-R4 The archive shall enable astronomers and engineers to access and use data which have been obtained with EVLA, regardless of where the information physically resides.

Priority: 1 Timescale: D

4.1-R5 The data shall be archived and made accessible (with access control) as soon as practical after they are taken or produced.

Priority: 2 Timescale: C

4.1-R6 The principal archive(s) should be easily accessed by users from all EVLA partners and major collaborators.

Priority: 2 Timescale: D

4.1-R7 There may be several “shadow” archives which hold all or subsets of data, which shall enable users over the world to access the observational data efficiently.

Priority: 3 Timescale: C

4.2 Raw Data

4.2-R1 The raw data in the archive shall include:

4.2-R1.1 raw interferometer data;

Priority: 1 Timescale: C

4.2-R1.2 header information;

Priority: 1 Timescale: C

4.2-R1.3 calibration data, including WVR data (at ~ 1 s intervals).

Priority: 1 Timescale: C

4.2-R2 All information describing the observation shall be accessible through the header (or an equivalent object).

Priority: 1 Timescale: C

4.2-R3 In the presence of irreversible data corrections, flagging, or modifications, such as RFI excision on time scales shorter than the integration time, the archive must be able to store and recognize both the corrected (modified) and uncorrected (original) data.

Priority: 1 Timescale: D

4.2-R4 Each scan within the data shall be identified by its type (“phase” calibrator, target observation, pointing scan, etc...).

Priority: 1 Timescale: D

4.2-R5 There shall be a mechanism to identify whether the observational data is scientifically meaningful or not (this is to allow a user to eliminate test observations for technical purpose, e.g., out-of-focus astronomical observation, etc.);

Priority: 2 Timescale: D

4.3 Environmental Data

4.3-R1 The environmental data in the archive shall include:

4.3-R1.1 all measured weather data (e.g., temperature, relative humidity, wind speed and direction, barometric pressure);

Priority: 1 Timescale: C

4.3-R1.2 any available atmospheric electron content data (from GPS, e.g.);

Priority: 2 Timescale: C

4.3-R1.3 any available RFI monitoring data;

Priority: 2 Timescale: C

4.3-R1.4 other atmospheric sounding data, if available (e.g., atmospheric phase monitor, tipping radiometer, FTS);

Priority: 3 Timescale: D

4.3-R2 Each item shall contain a time-stamp that is referenced to the data time stamps (i.e., not off by some large arbitrary offset due to internal clock slews within modules).

Priority: 1 Timescale: C

4.3-R3 All archived environmental data shall be indexed by time, to facilitate the linking of these data with appropriate observation periods.

Priority: 2 Timescale: D

4.4 Monitor and Control Data

4.4-R1 Monitor and control data stored in the archive shall include:

4.4-R1.1 instrumental parameters (pointing model parameters, referenced pointing offsets, antenna locations, transmission delays, subreflector rotation, focus curve parameters, etc...).

Priority: 1 Timescale: C

4.4-R1.2 status of instrumentation (e.g., error flags);

Priority: 2 Timescale: D

4.4-R1.3 monitor point information (e.g., module temperatures, voltages).

Priority: 3 Timescale: D

4.4-R2 The archive shall include all technical/environmental data measured by the EVLA system including times when the array was not observing.

Priority: 1 Timescale: C

4.4-R3 Each item shall contain a time-stamp that is referenced to the data time stamps (i.e., not off by some large arbitrary offset due to internal clock slews within modules).

Priority: 1 Timescale: C

4.4-R4 All archived technical data shall be indexed by time, to facilitate the linking of this data with appropriate observation periods.

Priority: 2 Timescale: D

4.5 Data Products

4.5-R1 Data products stored in the archive shall include:

4.5-R1.1 calibrated data (or the ability to generate on-the-fly), with the most up-to-date calibration;

Priority: 1 Timescale: D

4.5-R1.2 images/image cubes (or the ability to generate on-the-fly);

Priority: 1 Timescale: D

4.5-R1.3 the pipeline or post-processing software versions and data reduction scripts;

Priority: 2 Timescale: D

4.5-R1.4 data quality information (e.g., noise level and dynamic range, based on pipeline results);

Priority: 2 Timescale: D

4.5-R1.5 history of flux density determinations of calibration sources;

Priority: 2 Timescale: D

4.5-R1.6 catalog information (e.g., flux density, spectral index, source size) extracted from images or data;

Priority: 3 Timescale: D

4.5-R2 Submission of products to the archive shall be controlled.

4.5-R2.1 the Pipeline and Calibrator Analysis Tools shall have access to the archive to deposit resulting calibration information (possibly the fully calibrated data, or information on how to obtain it) and images;

Priority: 1 Timescale: D

4.5-R2.2 an EVLA staff member may submit the results of off-line reduction and imaging for inclusion in the archive (e.g., in cases where there was fault in the pipeline reduction);

Priority: 2 Timescale: D

4.5-R2.3 an observer or archive user, who has been granted authorization, may submit the results of off-line reduction and imaging for inclusion in the archive;

Priority: 3 Timescale: D

4.5-R2.4 the pipeline, staff, or authorized users shall be able to deposit catalog information extracted from data into the archive.

Priority: 3 Timescale: D

4.5-R3 The submission process shall provide a link between the submitted data and the original raw data.

Priority: 1 Timescale: D

4.5-R4 Images produced by the pipeline are stored in the archive when appropriate:

4.5-R4.1 For long integrations or large numbers of channels, the images are stored in the archive.

Priority: 1 Timescale: D

4.5-R4.2 For short integrations or small datasets, images shall be generated on-the-fly from the visibilities upon extraction from the archive.

Priority: 2 Timescale: D

4.5-R4.3 The decision between image storage and on-the-fly extraction shall be determined by the computing capability of the archive extraction pipeline, and may evolve with time.

Priority: 3 Timescale: D

4.5-R5 Updates to the calibration must be transparently incorporated in the archive.

4.5-R5.1 The archive should contain all calibrations which are applicable.

Priority: 1 Timescale: D

4.5-R5.2 The archive should support different versions of the same image, made with differing calibrations, imaging parameters, deconvolutions, or software.

Priority: 2 Timescale: D

4.5-R5.3 If recalibration by using better calibration algorithm and/or better calibration data is recommended by the EVLA, then the stored image will be recomputed based on the new calibration.

Priority: 2 Timescale: D

4.5-R6 Quick-look data products are not stored in the final archive by default (see pipeline requirements).

Priority: 3 Timescale: D

4.6 Project Data

4.6-R1 Project data stored in the archive shall include:

4.6-R1.1 all user (observer) input including the project proposal;

Priority: 1 Timescale: C

4.6-R1.2 operators log (electronic version);

Priority: 1 Timescale: C

4.6-R1.3 the Program Block as submitted to the Scheduling Tool;

Priority: 1 Timescale: D

4.6-R1.4 all Control Scripts actually executed by the real-time system;

Priority: 1 Timescale: D

4.6-R1.5 all Program Blocks, Scheduling Blocks, Control Scripts, or any other command submitted to the system (via GUI or directly typed in) during interactive or manual observing mode.

Priority: 2 Timescale: D

4.6-R2 Submission of Project data to the archive shall be controlled.

4.6-R2.1 an EVLA staff member may submit data to the archive as needed;

Priority: 2 Timescale: D

4.6-R2.2 an observer or archive user, who has been granted authorization, may submit data for inclusion in the archive;

Priority: 3 Timescale: D

4.6-R3 The submission process shall provide a link between the submitted data and the original raw data.

Priority: 2 Timescale: D

4.6-R4 It should be possible for the observer to insert notes into the archive related to the project, including observing notes, descriptions of why it was set up as it was, etc... (an “electronic logbook”).

Priority: 2 Timescale: D

4.6-R5 The archive shall include any relevant maintenance forms, e.g., detailing problems with receivers during observation.

Priority: 2 Timescale: D

4.6-R6 The archive shall have the ability to attach a persistent link to external archives and catalogs (e.g., DSS image) of the corresponding sky area.

Priority: 3 Timescale: E

4.6-R7 The archive shall have the ability to attach references and/or links to published papers (e.g., via ADS) that used the data.

Priority: 3 Timescale: E

4.7 Archive Search Tool

4.7-R1 There shall be an Archive Search Tool to access the archive.

Priority: 1 Timescale: B

4.7-R1.1 The Archive Search Tool shall be operated through a web-based GUI.

Priority: 2 Timescale: B

4.7-R1.2 The Archive Search Tool shall have a CLI to interrogate the archive from scripts or other Tools.

Priority: 2 Timescale: B

4.7-R1.3 The Archive Search Tool shall serve as a front end to the Archive Retrieval Tool, which manages the data extraction and delivery.

Priority: 2 Timescale: C

4.7-R2 The Archive Search Tool shall operate on supported platforms as designated by the project.

Priority: 2 Timescale: B

4.7-R2.1 The appearance and operation of the Archive Search Tool shall be platform independent.

Priority: 3 Timescale: D

4.7-R3 There shall be a variety of help and documentation facilities available from the UI and on the Internet for the Archive Search Tool. These shall include:

4.7-R3.1 An up-to-date and complete Reference Manual for the Archive Search Tool functions, operation, and installation.

Priority: 2 Timescale: B

4.7-R3.2 An introductory cookbook, including examples, designed to let a novice user, possibly without extensive knowledge of radio astronomy, know how to utilize the database efficiently and how to do data mining by using the archive.

Priority: 2 Timescale: C

4.7-R3.3 Interactive context-based help provided in the GUI.

Priority: 3 Timescale: E

4.7-R4 The Archive Search Tool interfaces shall present a look-and-feel suitable for the differing needs of types of archive users. These should include:

4.7-R4.1 a technical interface aimed at EVLA staff users of the archive, and for Archive Tool development and debugging;

Priority: 2 Timescale: D

4.7-R4.2 a user-friendly but comprehensive interface aimed at EVLA observers and archive users with knowledge of radio astronomy;

Priority: 2 Timescale: E

4.7-R4.3 a user-friendly interface aimed at novice users or astronomers outside the expert radio astronomy community (e.g., casual browsers, NVO users).

Priority: 3 Timescale: E

4.7-R5 The search criteria shall include all the information in the observation headers, including any information pointed to in sub-headers. They shall include (but not be limited to):

4.7-R5.1 Object name;

4.7-R5.2 Position on the Sky (Equatorial, Galactic, Ecliptic coordinates);

4.7-R5.3 Hour angle;

4.7-R5.4 Elevation;

- 4.7-R5.5 Observation Date;
- 4.7-R5.6 Integration Time;
- 4.7-R5.7 Molecular transition;
- 4.7-R5.8 Frequency;
- 4.7-R5.9 Array Configuration;
- 4.7-R5.10 Subarray;
- 4.7-R5.11 Observation mode;
- 4.7-R5.12 Whether observation is for target or calibration;
- 4.7-R5.13 Whether the object is a moving source or not;
- 4.7-R5.14 Angular resolution;
- 4.7-R5.15 Spectral resolution;
- 4.7-R5.16 Weather condition;
- 4.7-R5.17 Name of Principal Investigator;
- 4.7-R5.18 Project name;
- 4.7-R5.19 Project number;
- 4.7-R5.20 Title of the proposal;
- 4.7-R5.21 Observing Program;
- 4.7-R5.22 Program Blocks;
- 4.7-R5.23 Scheduling Blocks;
- 4.7-R5.24 Control Scripts;
- 4.7-R5.25 Telescope operator or duty astronomer;
- 4.7-R5.26 Reduction date;
- 4.7-R5.27 Data quality (noise level or dynamic range);
- 4.7-R5.28 A list of observatory supplied keywords;
- 4.7-R5.29 Other header info.

Priority: 1 Timescale: C

- 4.7-R6 The Archive Search Tool shall allow searching the observation database to see if observations for particular targets have been previously done.

Priority: 2 Timescale: D

- 4.7-R7 Regular expressions including wild card and ranges shall be available in search (although we do not envision full support of *regex* type expressions, but rather simple * and ? type wild card specification).

Priority: 2 Timescale: D

- 4.7-R8 The search criteria used for database search shall be shown with search results and shall be able to be modified.

Priority: 2 Timescale: E

- 4.7-R9 The Archive Search Tool shall allow search criteria based on a combination of search fields (e.g., the product of time and bandwidth).

Priority: 3 Timescale: D

- 4.7-R10 An archive user shall be able to browse all of the header information for requested data.

Priority: 2 Timescale: C

4.8 Archive Retrieval Tool

- 4.8-R1 There shall be an Archive Retrieval Tool to access the archive.

Priority: 1 Timescale: A

- 4.8-R1.1 The Archive Retrieval Tool shall have a CLI to access the archive from scripts or other Tools.

Priority: 1 Timescale: C

- 4.8-R1.2** The Archive Retrieval Tool shall be operated through a web-based GUI (possibly the same one as the Archive Search Tool).
Priority: 1 Timescale: C
- 4.8-R1.3** The Archive Retrieval Tool shall be accessible from the Archive Search Tool.
Priority: 2 Timescale: C
- 4.8-R1.4** The Archive Retrieval Tool shall be able to accept (properly verified) web-based search and extraction requests.
Priority: 2 Timescale: D
- 4.8-R1.5** The Archive Retrieval Tool shall be accessible from the Data Post-processing Package.
Priority: 3 Timescale: D
- 4.8-R2** The Archive Retrieval Tool shall receive the parameters for the retrieval from the calling interface or Tool, and in response, assuming the user has authorization, shall return the requested information such as:
- 4.8-R2.1** a raw uv data file;
Priority: 1 Timescale: C
 - 4.8-R2.2** header information;
Priority: 1 Timescale: C
 - 4.8-R2.3** environmental data;
Priority: 1 Timescale: C
 - 4.8-R2.4** calibration data;

Priority: 1 Timescale: C
 - 4.8-R2.6** a calibrated uv data file;

 - 4.8-R2.9** project data;
Priority: 2 Timescale: D
 - 4.8-R2.10** Run the pipeline on raw data with optional input parameters.
Priority: 3 Timescale: E
- 4.8-R3** For retrieval of raw or calibrated uv data files, optional averaging over time or frequency must be available.
Priority: 2 Timescale: D
- 4.8-R4** The archive user can select network transfer or physical data delivery (disk/tape) for data retrieval. The Archive Retrieval Tool shall have upper limits in total data size for each of them, which shall be determined by the EVLA project by taking into account the network bandwidth and the I/O speed.
Priority: 2 Timescale: D
- 4.8-R5** If an archive user requests a disk file transfer operation, then the Archive Retrieval Tool shall put data in a user-accessible directory. The user will be informed about the estimated transfer time. An email message can be requested at the end of the transfer.
Priority: 2 Timescale: D
- 4.8-R6** In any EVLA supported data transfer method, the data shall be delivered to a user within the EVLA project defined maximum time.
Priority: 2 Timescale: D
- 4.8-R7** At user request, a preview image (e.g., a small image cube) of the data found in the search shall be made available before actual data transfer.
Priority: 2 Timescale: B

4.8-R7.1 The preview image cube of the images and dirty beams shall be made either on-the-fly upon request or produced by the pipeline in advance (using the same criteria as for full images).

Priority: 2 Timescale: B

4.8-R7.2 If a user requests a preview image without specifying the frequency/velocity information in the line data search, the Archive Retrieval Tool shall provide a sensible default velocity integrated intensity image (e.g., 10 km/s for Galactic, 300 km/s for extragalactic, centered on the observer-specified rest frequency and tracking velocity).

4.8-R7.3 A simple image viewer for the preview image shall be also provided.

Priority: 2 Timescale: D

4.9 Relationship with the Virtual Observatory projects

4.9-R1 The archive shall be designed to meet the requirements, if practical, for on-going virtual observatory projects so that the EVLA data can be used more efficiently.

Priority: 2 Timescale: D

4.9-R2 Whatever the final shapes of virtual observatories become, the EVLA archive system shall be able to provide the following basic elements:

4.9-R2.1 the archived image

Priority: 2 Timescale: D

4.9-R2.2 image quality information for archived images

Priority: 2 Timescale: D

4.9-R2.3 data quality information for selected observations

Priority: 2 Timescale: D

4.9-R2.4 catalogues derived from the archive, if available

Priority: 3 Timescale: E

4.9-R3 The interface shall be designed to meet the requirements for virtual observatories. This assumes that the EVLA project receives the requirement information early enough to meet the project's development plan.

Priority: 2 Timescale: D

4.10 Proprietary requirements

Whether data are public or proprietary will usually be decided on the basis of the associated proposal, with rare exceptions based on the project, on the proposal group, or on an NRAO management decision. The default rules for access will be determined by NRAO management.

4.10-R1 Astronomical data may be public or proprietary.

4.10-R1.1 Technical data and header information shall be freely available;

Priority: 1 Timescale: C

4.10-R1.2 Calibration observations and staff test observations shall be public;

Priority: 1 Timescale: C

4.10-R1.3 Access to proprietary data shall be restricted to authorized users;

Priority: 1 Timescale: C

4.10-R1.4 Image data, and other data products, will be proprietary if the data from which the image is made is proprietary.

Priority: 1 Timescale: D

4.10-R1.5 Astronomical calibration observations, as well as the calibration pipeline output, can be extracted from the midst of otherwise proprietary data.

Priority: 2 Timescale: D

4.10-R2 The enforcement of access control to proprietary data will be consistent with EVLA policy.

Priority: 1 Timescale: C

4.10-R2.1 Proprietary data will be considered to be owned by the associated proposal. A mechanism shall be provided to designate the authors of that proposal as authorized users of that data.

Priority: 1 Timescale: C

4.10-R2.2 The EVLA staff shall have the capability of marking data associated with any given proposal or project as public.

Priority: 1 Timescale: C

4.10-R2.3 The EVLA staff shall have the capability of making proprietary data accessible to a designated user other than the owner.

Priority: 2 Timescale: C

4.10-R2.4 The data associated with a given proposal will (usually) be made public on the basis of the expiration of a proprietary interval after the latest observation done on the basis of the proposal. The archive software must recognize and enforce this interval.

Priority: 2 Timescale: D

4.10-R3 The Archive Retrieval Tool will maintain a record of data extracted.

Priority: 3 Timescale: D

4.10-R4 For data younger than a “data notification age”, the Archive Retrieval Tool will send an email to the last known address of the contact person of the associated proposal, informing them of the data being extracted and including the comment solicited above.

Priority: 3 Timescale: D

5 Pipeline data processing requirements

Most of the Pipeline data processing is done by the off-line processing package - what is contained herein describes only those things that could be considered 'pipeline-ish' which are in the on-line system: real- (or near-real) time calibrator analysis; and production of quick-look images and/or spectra. We present a single requirement for the Default Archive Image Pipeline which impacts the on-line system.

The real-time calibrator analysis is a set of higher level functions built around an algorithm capable of returning antenna-based complex gains given observed visibilities and a source model (what is in the current on-line system called ANTSOL, or in AIPS called CALIB), with some additional capabilities not tied to that specific algorithm.

We envision the quick-look pipeline as a subset of the full-blown off-line processing package pipeline which can execute quickly and return first-cut images and/or spectra to the operator(s) and observer(s).

5.1 Real-time Calibrator Analysis

5.1-R1 The Real-time Calibrator Analysis Tool shall be activated after each calibration scan, except during autophasing, where it must be able to run during scans.

Priority: 1 Timescale: C

5.1-R1.1 It should be possible to also specify shorter or longer intervals between activations, e.g., execute at the end of every integration, rather than just at the scan end, or, do not execute at the end of every scan, but rather only at the end of some number or grouping of scans.

Priority: 2 Timescale: D

5.1-R2 The Real-time Calibrator Analysis Tool shall determine the autophasing phase for each antenna, IF, and sub-band, and make it available to the real-time observing system.

Priority: 1 Timescale: C

5.1-R2.1 When autophasing, some measure of quality should be recorded and made available to operators and observers (an example might be the rms phase across the array).

Priority: 1 Timescale: C

5.1-R2.2 It shall be possible to select either on-the-fly autophasing (with appropriate simple source model input), which is done on each integration, or to specify that phases determined during calibrator scans are to be used to phase the array during scans on the astronomical source.

Priority: 1 Timescale: C

5.1-R2.2.1 For phases determined on the calibrator and applied to the astronomical source, simple extrapolation schemes should be available, including but not limited to: last sampled value, or mean of last N sampled values.

Priority: 3 Timescale: E

5.1-R3 The Real-time Calibrator Analysis Tool shall have the capability of taking visibility data along with a source model for a calibrator and deriving antenna-based complex gains therefrom.

Priority: 1 Timescale: C

5.1-R3.1 There should be a capability of specifying simple u-v restrictions on the input visibilities (e.g., boxes or circles in the u-v plane).

Priority: 1 Timescale: C

5.1-R3.2 There should be a capability of specifying the following simple parametric source models:

5.1-R3.2.1 point source (flux density, position, polarization, and the variation of these with frequency);

Priority: 1 Timescale: C

5.1-R3.2.2 elliptical gaussian (flux density, position, major and minor axis width and position angle, polarization, and the variation of these with frequency);

Priority: 3 Timescale: D

- 5.1-R3.2.3** elliptical limb-darkened disk (flux density, position, major and minor axis width and position angle, limb-darkening parameter, polarization, and the variation of these with frequency);
Priority: 3 Timescale: D
- 5.1-R3.2.4** combinations of the above simple single sources.
Priority: 3 Timescale: D
- 5.1-R3.3** There should be a capability of specifying more complex source models, via input as a FITS image cube or set of CLEAN components as a function of polarization and frequency (or any other, relatively simple and easily manipulated, image-plane description).
Priority: 2 Timescale: D
- 5.1-R4** The Real-time Calibrator Analysis Tool should have the capability of determining the current phase stability of the instrument + atmosphere, given the visibilities and complex gain solutions. This quantity should be accessible by the Scheduling Tool.
Priority: 2 Timescale: D
- 5.1-R5** The Real-time Calibrator Analysis Tool should have the ability to recognize bad data (via some auto-flagging procedure, or by analyzing residuals from its own gain solutions) and reject them. This includes RFI recognition. Such data and flagging must be reported to operations.
Priority: 2 Timescale: D
- 5.1-R6** The Real-time Calibrator Analysis Tool should have the capability to recognize misbehaving antennas based on its results, and should be able to report this information to the real-time system and to operations.
Priority: 2 Timescale: D
- 5.1-R7** The Real-time Calibrator Analysis Tool should support the following higher level functions:
- 5.1-R7.1** antenna location determination;
Priority: 1 Timescale: D
 - 5.1-R7.1.1** residuals from the solutions shall be examined, and poor solutions reported to operations staff.
Priority: 2 Timescale: D
 - 5.1-R7.2** global pointing model determination, per antenna;
Priority: 1 Timescale: D
 - 5.1-R7.2.1** residuals from the solutions shall be examined, and poor solutions reported to operations staff.
Priority: 2 Timescale: D
 - 5.1-R7.3** pointing offset determination, per antenna and frequency band;
Priority: 1 Timescale: C
 - 5.1-R7.3.1** arbitrary 'pointing patterns' (e.g., 5-point, triangles, the 'Craig cross', etc...) shall be allowable;
Priority: 2 Timescale: D
 - 5.1-R7.3.2** residuals from the solutions shall be examined, and poor solutions reported to operations staff.
Priority: 2 Timescale: D
 - 5.1-R7.3.3** single-dish pointing determination should also be supported;
Priority: 3 Timescale: D
 - 5.1-R7.4** complex bandpass, per antenna, given frequency band, correlator and backend setup;
Priority: 1 Timescale: C
 - 5.1-R7.5** focus, per antenna and frequency band;
Priority: 1 Timescale: D
 - 5.1-R7.5.1** arbitrary 'focus patterns' shall be allowable;
Priority: 2 Timescale: D
 - 5.1-R7.5.2** residuals from the solutions shall be examined, and poor solutions reported to operations staff.
Priority: 2 Timescale: D
 - 5.1-R7.5.3** single-dish focus determination should also be supported.
Priority: 3 Timescale: D
 - 5.1-R7.6** delays (including the crossed-hands), per antenna, frequency band, IF, and sub-band;
Priority: 1 Timescale: D

5.1-R7.7 polarization calibration terms, per antenna and frequency band;

Priority: 1 Timescale: D

5.1-R7.8 flux density scale determination (i.e., the conversion factor from correlation coefficient to Janskys);

Priority: 1 Timescale: D

5.1-R7.9 TIP analysis to derive antenna parameters (Tcal) and atmospheric opacity at the observed frequency;

Priority: 2 Timescale: D

5.1-R7.10 antenna aperture efficiency determination, per frequency, given knowledge of source flux density, atmospheric opacity, and other system quantities.

Priority: 3 Timescale: E

5.1-R8 The outputs from the Real-time Calibrator Analysis Tool should be archived (probably by passing them to the Archive Tool).

Priority: 1 Timescale: D

5.1-R9 The outputs from the Real-time Calibrator Analysis Tool should be available to the quick-look Pipeline Tool.

Priority: 1 Timescale: D

5.2 Quick-look Pipeline

The quick-look pipeline produces images and/or spectra on short timescales for feedback during observing - both to the operator and to the observer. It is most likely that this is a streamlined version of the full off-line science pipeline.

5.2-R1 The quick-look Pipeline Tool shall be activated automatically under given conditions (e.g., after a certain time interval, after each scheduling block, etc...). These intervals should be specified in the Observing Tool. The output from the Tool shall be accessible to operators and observers.

Priority: 1 Timescale: D

5.2-R2 It should also be possible to run the quick-look Pipeline Tool whenever requested by the staff astronomer, operator, or observer (assuming a reasonable request). Inputs will be requested (the Pipeline data reduction setup component of the Observing Tool or its equivalent will be executed), and an estimate of the time to complete the requested operations will be given.

Priority: 1 Timescale: D

5.2-R3 It should be possible to abort execution of the quick-look Pipeline Tool gracefully, including cleaning up of files, killing all spawned processes, etc...

Priority: 1 Timescale: D

5.2-R4 The time-lag between when data is collected by the real-time system and when it is available to the quick-look Pipeline Tool should be less than 30 seconds. This may guide a decision on whether data is all archived first, and then retrieved from the archive into the Tool, or fed directly from the real-time system into it (the fear is that the time lag between when data is collected and when it is actually available in the archive could be as long as minutes).

Priority: 1 Timescale: D

5.2-R5 The quick-look Pipeline Tool should use the pipeline data reduction parameters as specified in the Observing Tool, including the heuristic for data reduction.

Priority: 1 Timescale: D

5.2-R5.1 If the quick-look Pipeline Tool is being run on request by a person, then that person should be able to modify the pipeline data reduction parameters for that particular run of the Tool, i.e., that person should have access to the Pipeline data reduction setup component of the Observing Tool.

Priority: 2 Timescale: D

5.2-R6 The quick-look Pipeline Tool shall be able to process data in multiple subarrays.

Priority: 1 Timescale: D

5.2-R7 The quick-look Pipeline Tool should apply all flags generated by the real-time system, and should include facilities for generating flags based on the data itself, either of calibrators or of data taken on the target object. This includes recognition of RFI. Flags generated from data taken on the target object must be reported to operations. The setup parameters of the pipeline shall include a list of such facilities to be used, and a selectable level of flagging, e.g., light, nominal, heavy.

Priority: 1 Timescale: D

5.2-R8 The quick-look Pipeline Tool should create calibrated image cubes and/or spectra, with the best calibration information currently available, including:

5.2-R8.1 conversion of correlation coefficients into flux density, including any of the following corrections not already made to the data: Tsys, gain, opacity, Van-Vleck, flux density scale;

5.2-R8.2 bandpass calibration;

5.2-R8.3 polarization calibration;

5.2-R8.4 transfer of amplitude and phase correction from calibrator(s) (using the scaling factor between the calibration and observing frequencies if necessary);

5.2-R8.5 WVR phase correction, if desired and available.

Priority: 1 Timescale: D

5.2-R9 The following calibration modes shall be supported:

5.2-R9.1 calibration transfer (including fast switching);

Priority: 1 Timescale: D

5.2-R9.2 self-calibration.

Priority: 1 Timescale: D

5.2-R10 The quick-look Pipeline Tool shall always compute the dirty image of astronomical sources when directed to do so (the operator or astronomer should be able to select spectra only), using the fastest algorithm possible. The supported observing modes should include:

5.2-R10.1 normal single-field synthesis;

Priority: 1 Timescale: D

5.2-R10.2 multiple source observations (“snapshots”);

Priority: 1 Timescale: D

5.2-R10.3 mosaicing;

Priority: 2 Timescale: E

5.2-R11 The quick-look Pipeline Tool should deconvolve the dirty images, if possible in the short time allowed, using a fast deconvolution algorithm, with minimal controlling inputs.

Priority: 1 Timescale: D

5.2-R12 The processing described in the previous requirement shall be done for:

5.2-R12.1 the continuum data;

5.2-R12.2 the line-averaged spectra, over a pre-defined velocity or frequency range (defined either by the astronomer or by the staff astronomer or operator).

Priority: 1 Timescale: D

5.2-R13 The quick-look Pipeline Tool should allow for a modest number of self-calibration + imaging/deconvolution iterations, if time allows.

Priority: 2 Timescale: D

5.2-R14 The quick-look Pipeline Tool should complete its execution on a time scale which is reasonable for astronomy decision making (current thinking is a few minutes at most).

Priority: 2 Timescale: D

5.2-R15 It should be possible to reproduce any function of the quick-look Pipeline Tool in the off-line data reduction package.

Priority: 2 Timescale: D

5.3 Default Archive Image Pipeline

It is envisioned that when all of the data have been collected for a given Program, a pipeline will be invoked which creates the default image for the archive for that program. There is a single requirement on the on-line software that connects with this pipeline, which we specify here. The rest of the requirements for that pipeline are contained in the off-line processing document.

5.3-R1 The default image pipeline needs to be triggerable from the on-line system (i.e., the on-line system recognizes that a Program has been completed, and sends a signal to the default image pipeline that it should commence with its processing. The default image pipeline may have to delay execution until all necessary calibration quantities are obtained, but it should have the capability of receiving the indication from the on-line system that all of the visibility data has been collected for that program).

Priority: 2 Timescale: D

5.4 Atmospheric Model

5.4-R1 Atmospheric modelling shall be available in the Pipeline and to the Scheduling Tool. The model shall be able to predict the absorption, emission and pathlength on the line of sight through the atmosphere at all EVLA bands. The prediction will be based on measured data, including, but not limited to:

5.4-R1.1 measured atmospheric parameters at the site: temperature, pressure, humidity;

5.4-R1.2 measured atmospheric emission in the observed EVLA bands;

5.4-R1.3 measured WVR data;

5.4-R1.4 measured atmospheric profiles of temperature and water content if available from atmospheric sounders;

5.4-R1.5 measured optical depths from tipper meters and/or FTSs, if available;

5.4-R1.6 measured electron content from GPS or other techniques.

Priority: 2 Timescale: D

5.4-R2 Atmospheric modelling shall be used to derive the opacities in all astronomical bands in use, in order to correct the observed amplitudes at various elevations.

Priority: 2 Timescale: D

5.4-R3 Atmospheric modelling shall be able to provide the conversion factors between WVR data and the water contribution to the astronomical phase in all EVLA bands.

Priority: 2 Timescale: D

5.5 The Astronomer's "what's up" Screen

The astronomer shall be able to access via the internet a GUI which displays information about observations currently being undertaken by the EVLA. BGC has coined the term: "what's up screen" for this, and we adopt that terminology here. It is a screen that makes available, e.g., information on current meteorological parameters, phase stability, observing Program, source, real-time calibrator analysis output, quick-look pipeline output, raw visibility information, etc...

5.5-R1 There shall be made available over the internet an astronomer's "what's up" screen, giving current observational and instrumental information for the EVLA.

Priority: 1 Timescale: C

5.5-R2 The following quantities and their time histories (where appropriate) shall be able to be displayed via the "what's up" screen:

5.5-R2.1 current date and time.

Priority: 1 Timescale: C

5.5-R2.2 begin and end time of current scan.

Priority: 1 Timescale: C

5.5-R2.3 source being observed, with frequency or velocity (selectable), and position (selectable as sky or azimuth/elevation).

Priority: 1 Timescale: C

5.5-R2.4 correlator setup.

Priority: 1 Timescale: C

5.5-R2.5 surface meteorological parameters (temperature, dew point temperature [or humidity], wind speed and direction, pressure);

Priority: 1 Timescale: C

5.5-R2.6 auxiliary monitoring device output:

5.5-R2.6.1 Atmospheric Phase Monitor - raw data and related derived quantities (structure function, rms phase, corner time, exponent);

Priority: 1 Timescale: C

5.5-R2.6.2 current opacity estimate for all observing bands, from either surface data, seasonal estimate, TIPS of the array itself, separate tipping radiometers, separate FTS devices, etc...

Priority: 2 Timescale: D

5.5-R2.6.3 Water Vapor Monitor byproduct data (e.g., derived precipitable water vapor from WVM data);

Priority: 2 Timescale: E

5.5-R2.6.4 RFI monitor (if available);

Priority: 3 Timescale: E

5.5-R2.6.5 Atmospheric electron content information (if available, via GPS, e.g.);

Priority: 2 Timescale: D

5.5-R2.7 visibility amplitude and phase, on a specified baseline, over a specified frequency or velocity range, for all polarization products (u, v, and w should also be displayed).

Priority: 1 Timescale: C

5.5-R2.8 array properties, such as:

5.5-R2.8.1 array status (e.g., number of functioning antennas, error flags);

Priority: 1 Timescale: C

5.5-R2.8.2 current system temperature on each antenna at the observing frequency;

Priority: 1 Timescale: C

5.5-R2.8.3 the *uv* coverage and dirty beam, integrated over the current session, for a chosen target source;

Priority: 2 Timescale: D

5.5-R2.8.4 the thermal noise rms reached since the beginning of the observing session (from theory, using actual system temperatures);

Priority: 2 Timescale: D

5.5-R2.8.5 for mosaic observations: the above quantities for each pointing center.

Priority: 3 Timescale: E

5.5-R2.9 results of real-time calibrator analysis output for the current session, including any focus, delay, reference pointing, complex gain, etc..., data. There should be a variety of options, to control the display parameters, to plot the variation of these results with time, to allow the staff astronomer and operator to monitor one antenna or baseline in particular, etc. Since it is required that the EVLA staff can efficiently check out the status of ongoing observations, all the plots should be reasonably simple, and the plot option should be able to quickly be changed by the staff astronomer/operator.

Priority: 1 Timescale: C

5.5-R2.10 the (uncalibrated) spectrum observed on an astronomical source (amplitude/phase or real/imaginary) with various options such as:

5.5-R2.10.1 time integration;

Priority: 1 Timescale: C

5.5-R2.10.2 choice of a single baseline (antennas selectable) or all baselines;

Priority: 1 Timescale: C

5.5-R2.10.3 vector or scalar averaging.

Priority: 1 Timescale: C

5.5-R2.11 the resultant image cube and/or spectrum from all quick-look pipeline executions related to the current observing session.

Priority: 1 Timescale: D

5.5-R2.12 pulsar information, including:

5.5-R2.12.1 Pulsar name and its current period (calculated for ongoing observation);

Priority: 2 Timescale: E

5.5-R2.12.2 Dispersion measure (provided by astronomer) and derived quantities (dispersion smearing time at observed frequency/bandwidth);

Priority: 2 Timescale: E

5.5-R2.12.3 Time bin configuration, as required by hardware;

Priority: 2 Timescale: E

5.5-R2.12.4 A time averaged pulse profile made using time bins. A dispersion correction should be applied to the data. This display could be analogous to the display of an uncalibrated spectrum, with similar options. If pulse-phase dependent trigger(s) is/are generated (for gating or for driving external hardware), it/they should be marked. The zero-phase (as defined by the provided polynomial) should be marked also.

Priority: 2 Timescale: E

5.5-R3 The time-lag between when data is collected by the real-time system or produced from the quick-look Pipeline Tool and when it is available to the “what’s up” screen should be less than 10 seconds. This may guide a decision on whether data is all archived first, and then retrieved from the archive into the “what’s up” screen, or fed directly from the real-time system into it (the fear is that the time lag between when data is collected and when it is actually available in the archive could be as long as minutes).

Priority: 1 Timescale: C

5.5-R4 It should also be possible for the staff astronomer, operator, or observer to initiate execution of the quick-look pipeline from the “what’s up” screen (assuming a reasonable request).

Priority: 2 Timescale: D

5.5-R4.1 The person initiating the execution of the quick-look pipeline should be able to modify the pipeline data reduction parameters associated with the Program Block, i.e., should have access to the Pipeline data reduction setup component of the Observing Tool.

Priority: 2 Timescale: D

5.5-R5 There should be a link to the Scheduling Tool web page (see Requirement 3.1-R15.1) from the “what’s up” screen.

Priority: 2 Timescale: D

5.5-R6 There should be a link to the Project web page from the “what’s up” screen (see Requirement 3.1-R11.4).

Priority: 2 Timescale: D

A Definitions and descriptions

In this Section we introduce the main entities, used to manage the whole observing process, that are constantly referred to in the requirements. These entities have some kind of hierarchical structure that will be further refined at the analysis stage of software development.

Proposal:

An observer submits a proposal to perform a set of observations. At the time of submission, a proposal has associated with it all quantities described in section 1 under Requirements 1-R6, 1-R7, 1-R8, 1-R9, 1-R10, and 1-R17.

Although there certainly are groups of proposals (and the submission tool should have a box to list associated or previous proposals), it is proposed to take no formal cognizance of them, with the exception that the proprietary period of a group of proposals may be considered to extend through the last member of the group.

Project:

When approving a proposal, the observing program committee creates one or more Projects. A Project is a scientifically independent subset of the observations proposed in the Proposal which have been approved by the observing program committee. Each project may have a different scientific rating.

The project refers back to the proposal through the proposal identification code. It has associated with it additional information:

- A project identification code;
- A list of requested bands (possibly subset of those in proposal);
- A list of requested configurations (possibly subset of those in proposal);
- A scientific rating assigned by the observing program committee;
- An optional source list (subset of that in proposal if that exists);
- A limitation of observing resources (reassessment of sensitivity level, maximum observing time);
- Number and status (e.g., Observed, Partially Observed, Not Observed) of the underlying programs.

Program:

Within each project, observations in different configurations are each assigned to a separate program.

Each program has associated with it an observing description (a Program Block), which describes (in greater detail than is available in the proposal) how the observations are to be completed for the program.

The Program Block is a set of Scheduling Blocks (SB).

The program refers back to the proposal and project through the proposal and project identification codes.

A Program has associated with it the additional information:

- Configuration(s) in which its Scheduling Blocks may be run (including whether move time is acceptable). Note that if multiple configurations are required, then it must be split into separate Programs - if any one of several configurations are acceptable, they can be specified here;
- List of requested bands (a subset of those in the project);
- A limitation of observing resources;
- Total array time scheduled under the aegis of this program;
- Sensitivity weighted time scheduled under the aegis of this program;
- An optional scientific rating assigned by the observing program committee;
- A Program Block (observing description).

Program Block (PB):

The set of Scheduling Blocks derived from a single Program that are to be submitted to the Scheduling Tool for queuing at the same time. An observer would normally create these in a single run of the Observing Tool.

Scheduling Block (SB):

When the observer is notified that their project is approved for observing, they make a set of scheduling blocks. The division into scheduling blocks is under the observer's control, but for standard observing modes, a template is provided, and observers are warned that deviating from the spirit of the templates may result in a reduced likelihood of being scheduled. The SB refers back to the proposal through the proposal, project, program, identification code. It has associated with it additional information:

- A Control Script to be executed;
- A maximum single execution duration of the SB;
- A maximum total observing time to be spent using this SB;
- The sensitivity goal to be reached by repeated executions;
- The maximum atmospheric water vapor content required for scheduling (normally defaulted from frequency);
- The maximum phase fluctuation (after phase correction) required for scheduling (normally defaulted from technical characterization, frequency and requested angular resolution);
- An optional, observer assigned relative priority to be used when scheduling. This is used for dependencies between SBs in a given project;
- A maximum pointing error (systematic and random components) including wind speed;
- An optional preferred LST range, and preference for rising sources, which may be used to increase the likelihood of contiguous UV tracks, over a system preference for high elevations;
- A list of dates for which priority modifiers exist (either lowering or raising priority);
- A list of alternative calibrators, with an indication of time range to be used (used, e.g., for moving target sources);
- Status information, including at least:
 - The number of successful executions;
 - The integration time, and theoretical rms for each execution;
 - The total integration time, and current resulting theoretical rms;
 - The total array time used so far;
 - Whether the block goals are reached.

Each source in the SB should be noted as either a member of the proposal source list or a calibrator.

Control Script:

A script in the language of the on-line computer system directing the EVLA or a subarray thereof to collect data with a specified receiver setup, phase tracking center, and antenna pointing. The EVLA is operated by having the Scheduling Tool, human operator, or observer pass a Control Script to the real-time computer system. Specifically, a Control Script contains:

- A simple driving pattern for each antenna;
- A simple driving pattern for the array phase center;
- A single receiver and frequency setup (although this setup may specify more than one receiver/frequency);
- A single correlator configuration.

We note here that there is an implementation choice to be made regarding subarrays. We see at least two ways of allowing for subarrays:

- A single SB contains all of the information to define all of the different subarrays needed;
- Each subarray requires a separate SB.

In the first case, either an SB must be allowed to spawn multiple Control Scripts, or a CS must allow for multiple versions of the above quantities (driving pattern, frequency, etc...) within it. We do not recommend one over the other, merely point out that the implementation of subarray support may require a change in the definitions of Scheduling Blocks and Control Scripts slightly.

Preambles and postambles are particular versions of Control Scripts, and have several possible functions. The purpose of these scripts is to collect calibration data for use in the data reduction phase, e.g.:

- Flux density scale calibration;
- Bandpass calibration;
- Polarization leakage term calibration;
- Receiver phase difference calibration.

Observing Session:

The time contiguous execution of one or more scheduling blocks in a program constitutes an observing session. An observing session has a common preamble and postamble for each SB which requires one.

Scan:

The scan is the lowest level object normally used by an observer. It is a sequence of one or more observations that share a single goal. A scan is usually a single observation of a target source or a calibrator, but, for instance, pointing and focus scans involve a pattern of observations.

Record:

A Record is the minimal amount of data taking that can be commanded within a Control Script. It is highly desirable that it should be a simple enough element so that the script language may be used to define the content of scans (at the staff member/expert level), as a means to develop and debug new observing modes. Ideally a single generic command would cause a Record to be obtained as described by the Control Script. An example of a Record is a single pointing within a holography Scan (which might contain several Integrations).

Integration:

An Integration is the basic written unit of data. It is the average of a set of Correlator Dumps.

Correlator Dump:

A Correlator Dump corresponds to the minimum available integration time output from the correlator hardware.

Pipeline:

A sequence of data reduction operations performed according to a script present at the initiation of Pipeline operation, usually resulting in an image cube. The script may include conditional operations based on results or conditions generated by individual data reduction operations. A Pipeline Tool consists of a supervisor to execute such scripts, a collection of standard scripts, and an interface to the archive or the real-time system, from which it may extract the data upon which it operates.

Stringency:

The stringency is formally defined as: $S = t_a/t_p$, where t_a is the total time available for scheduling, and t_p is the time during which the required conditions are met. So, observations requiring conditions which occur only very rarely have a high stringency, while those which only require average conditions would have a stringency of 2, and those which could be observed at any time have a stringency of 1. See Appendix A of the ALMA ASAC report of October 2002 for a complete description and study of this quantity for ALMA.

Real-time System:

The software that actually controls the EVLA at the hardware level. This software is designed and implemented by the EVLA project personnel.

On-line System:

The portion of the e2e software which directly interfaces to the real-time system software, namely the Scheduling Tool, the Archive Tool, the Real-time Calibrator Analysis Tool, the quick-look Pipeline Tool, the Astronomer's What's Up Screen, and any other required software (for instance, that required to do the interfacing). This software is designed and implemented by the e2e project and Data Management division personnel.
