# **SECTION 3 — HAZARDS IDENTIFICATION**

#### **ROUTES OF EXPOSURE**

#### **UNUSUAL FIRE AND EXPLOSION HAZARDS**

#### PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE
